TYPE I SKIERS:

- ski conservatively
- favor lower than average release/retention settings. This corresponds to an increased risk of inadvertant binding release in order to gain increased release capability in a fall.
- prefer slower speeds
- prefer easy, moderate stops
- **Type I** settings apply to "entry-level skiers uncertain of their classification ASTM F939"

TYPE II SKIERS:

- ski moderately
- all skiers who do not meet all the descriptions of either **Type I** or **III**
- prefer a variety of speeds

TYPE III SKIERS:

- ski aggressively
- prefer steeper and more challenging terrain
- favor higher than average release/retention settings. This corresponds to decreased releasability in a fall in order to gain a decreased risk of inadvertant binding release.
- normally ski at high speeds

7. I agree to hold harmless and indemnify the ski shop and its owners, agents and employees, as well as the equipment manufacturers and distributors for any loss or damage, including any that results from claims for personal injury, death or property damage related to the use of this equipment.
8. I understand that there are inherent and other risks involved in the sport of snow skiing, for which this equipment is to be used, that injuries are a common and ordinary occurrence of the sport, and I freely and voluntarily assume those risks.
9. I understand that a ski-binding-boot system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release, and it is, therefore, no guarantee of my safety.
10. I hereby release from any legal liability the ski shop and its owners, agents and employees, as well as the manufacturers and distributors of this equipment from any and all liability for damage and injury or death to myself or to any person or property resulting from the selection, installation, maintenance, adjustment or use of this equipment and for any claim based upon negligence, breach of warranty, contract or other legal theory, accepting myself the full responsibility for any and all such damage, injury or death which may result.
11. This agreement is governed by the applicable law of this state or province. If any part of this agreement is determined to be unenforcable, all other parts shall be given full force and effect.
