\_\_\_\_\_ **WAIVER OF LEGAL RIGHTS.** In consideration of all of the above and also in consideration of the equipment being rented to me, or at my request, I hereby release Westgate Sports Inc., it's owners, agents, and employees from any and all liability for damage and injury to myself or to any person or property resulting from, among other things, negligence, installation, maintenance, the selection, adjustment, and use of this equipment. I accept full and complete responsibility for any and all such damage or injury or death which may result. I agree to hold harmless and indemnify result from my use of this equipment including a claim from anyone with whom I may come into physical contact while using the equipment.
